Deaths of Alfred C. Kinsey and Andrew P. Ushenko

Alfred Charles Kinsey, Director of the Institute for Sex Research, and Andrew Paul Ushenko, Professor of Zoology, died on August 25, 1956. Andrew Paul Ushenko, Professor of Zoology, died on September 11, 1956. The Board unanimously adopted the following resolutions (Hickam-McCarty):

RESOLUTION

WHEREAS: The death of Alfred Charles Kinsey on August 25, 1956, has deprived Indiana University, and the world of science and research, of a teacher and scholar of the first magnitude; and

WHEREAS: The members of the Board of Trustees of Indiana University have long recognized the great ability of Alfred Charles Kinsey as a respected authority in his chosen field of zoology, and as the leader of our times in research to discover the solution to complex problems of human behavior; and
